Get it together and consolidate your super

Super consolidation form



If you have had more than one job, chances are you have more than one superannuation policy – which also means you are probably paying more than one set of fees.

You have the option of combining all of your super benefits into a single fund, which means you'll pay only one set of fees, receive one set of paperwork, and have more control over your super investment.

However, in some cases consolidation may not be in your best interests. Please refer to the important information below. We also recommend that you speak to your financial adviser before choosing to consolidate your super.

If you decide to consolidate, follow these three steps:

Step 1

Gather your statements

You can find your policy number(s) by checking your old super statements. If you can't find your old statements, contact your former employers who may be able to help you find the companies that hold your old super funds.

Step 2

Fill out the Super consolidation form

Complete steps 1 and 2 of the form on the reverse side of this page. You can photocopy the form if you have more than one super benefit to consolidate, **just remember to sign each form.**

Step 3

Send it back to us

Send your completed Super consolidation form(s) to:

We'll contact your other super funds on your behalf and consolidate your super benefits into your nominated AXA super account.

Step 1 Details of old fund

Complete the details of your old super account

Your most recent member statement from your old fund should provide the information needed to complete this section. Your previous employers may also have these details. You may also want to call the Australian Taxation Office (ATO) Superannuation Information Line on 13 10 20.
